## 1. Introduction

The FinCEN Designation of Exempt Person (FinCEN DOEP | Form 110) Electronic Filing Requirements XML Schema 2.0 User Guide outlines the business and validation rules to support the electronic batch transmission of the FinCEN DOEP. Electronic filing of this report will be through the Bank Secrecy Act (BSA) E-Filing System operated by the Financial Crimes Enforcement Network (FinCEN). BSA E-Filing users who intend to file the FinCEN DOEP batch XML should be familiar with FinCEN regulations, Extensible Markup Language (XML) and the FinCEN XML schemas. ## 2. FinCEN DOEP XML Schema Overview

Before you begin submitting your BSA data to FinCEN's BSA E-Filing System ([bsaefiling.fincen.treas.gov](https://bsaefiling.fincen.treas.gov)) via XML batch, you must first review the required schemas to assist you with constructing and testing your XML batch file.. These schemas define the requirements by which the FinCEN DOEP XML batch file must be constructed, such as which elements are required and which are not required, what are the appropriate values you may enter for certain elements, and what sequence the elements should appear in when building the batch. ### 2.1. File Organization

This section describes the general formatting requirements for FinCEN DOEP XML batch reporting. The diagrams that follow provide a visual representation of the XML batch file layout from a high-level perspective.

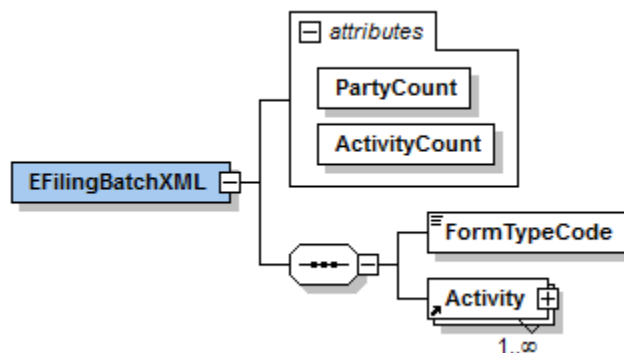
#### 2.1.1. XML declaration (prolog)

The XML declaration specifies the XML version and character encoding used in the file. It must appear on the first line of the file.

#### 2.1.2. EFilingBatchXML

This is the root element and serves as the container for all FinCEN DOEP documents recorded in the batch. It must be the first element recorded in the file.

The EFilingBatchXML element is parent to the <Activity> element. This complex element is the container for each FinCEN DOEP document in the batch. All BSA data related to a single FinCEN DOEP document must be recorded within the <Activity> element. The count of <Activity> elements in the batch will depend on the count of FinCEN DOEP documents being reported.

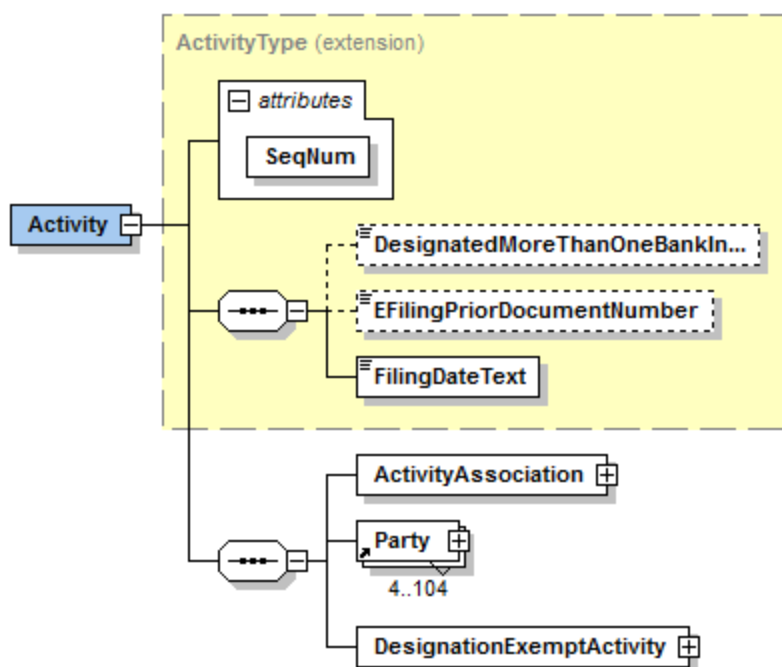


### 2.1.3. Activity

Each FinCEN DOEP document in the batch must begin with the <Activity> element. This element identifies all information related to a single FinCEN DOEP. This information includes the transmitter of the batch file, the transmitted contact, the exempt person, the filer, the affiliated bank (if any), the authorized official, and any details about the type of designation being filed. There is no limit to the number of <Activity> elements that may be recorded in the batch. However, the total size of the batch file must not exceed 60MB.

The <Activity> element is parent to the following complex element(s):

- **ActivityAssociation.** This element is the container for the type of filing (i.e. Initial designation, Exemption amended, or Exemption revoked) for the FinCEN DOEP.
- **Party.** This element is the container for any person (individual or entity) associated with the FinCEN DOEP, specifically, the transmitter [of the batch file], the transmitter contact, the exempt person, the filer, the affiliated bank (if any), and the authorized official.
- **DesignationExemptActivity.** This element is the container for the type of exempt person and the effective date of the exemption.

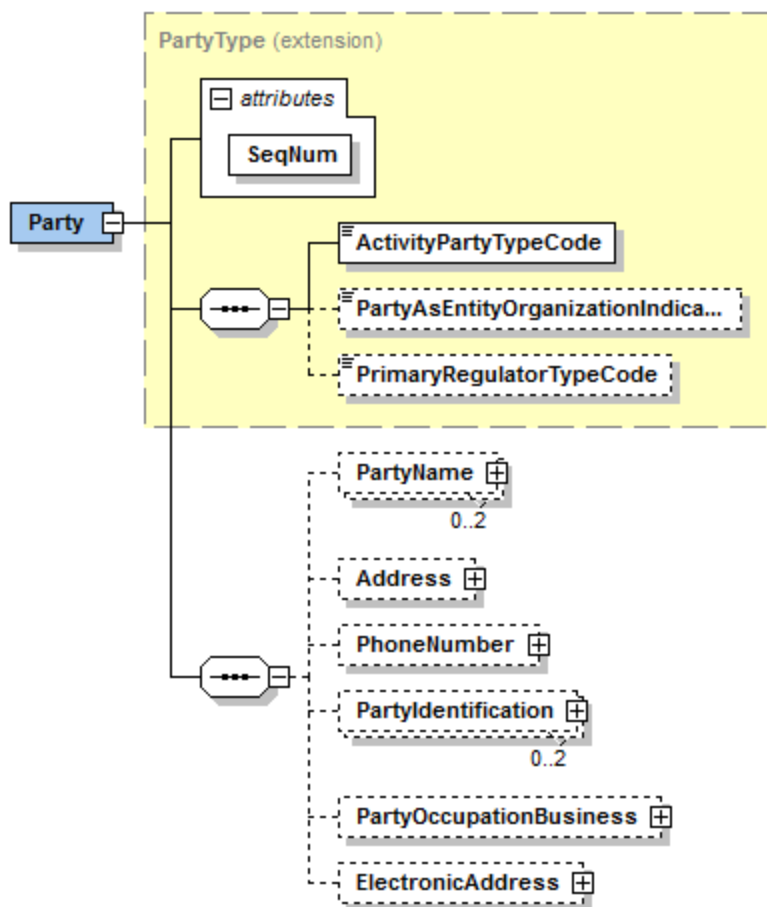


### 2.1.4. Party

Each FinCEN DOEP activity in the batch must include a separate Party element identifying the following persons:

- Transmitter (required, one only).
- Transmitter Contact (required, one only).
- Exempt Party (required, one only).
- Exempt Filer Bank (required, one only).
- Exempt Affiliated Bank (required if known, multiples permitted up to 99).
- Authorized Official (required if known, one only).

A maximum occurrence of 104 total Party elements may be recorded at the activity level for each FinCEN DOEP activity in the batch.



#### Transmitter (Required | 1)

This is the person (individual or entity) handling the data accumulation and formatting of the batch file. Each FinCEN DOEP Activity element in the batch must include a Party element that identifies the batch transmitter. The Transmitter telephone number must relate to the individual recorded as the Transmitter Contact. *The batch transmitter should be identical for each FinCEN DOEP.* There must be one occurrence of this party for each FinCEN DOEP Activity in the batch.

#### Transmitter Contact (Required | 1)

This is the official contact individual for the transmitter. Each FinCEN DOEP Activity element in the batch must include a Party element that identifies the point of contact for the batch transmitter. *The transmitter contact should be identical for each FinCEN DOEP.* There must be one occurrence of this party for each FinCEN DOEP Activity in the batch.

#### Exempt Party (Required | 1)

This is the person (individual or entity) to be designated as exempt. There must be one occurrence of this party for each FinCEN DOEP Activity in the batch. This party corresponds with Part II of the FinCEN DOEP.

#### Exempt Filer Bank (Required | 1)

This is the bank that is filing the FinCEN DOEP. There must be one occurrence of this party for each FinCEN DOEP Activity in the batch. This party corresponds with Part III of the FinCEN DOEP.

#### Exempt Affiliated Bank (Required if known | 0-99)



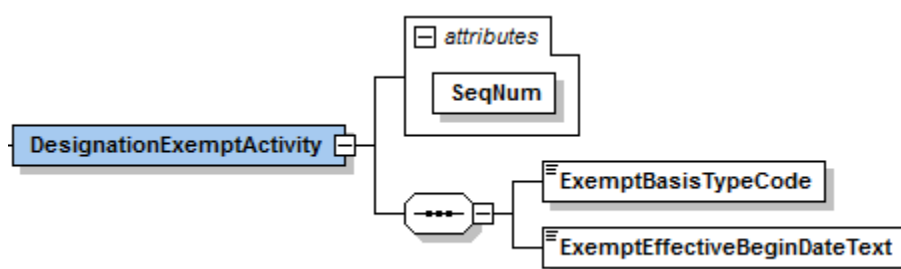
This is the bank subsidiary that will treat the customer as an exempt person. There can be up to 99 occurrences of this party for each FinCEN DOEP Activity in the batch. This party corresponds with the Affiliated Bank section of the FinCEN DOEP.

Authorized Official (Required if known | 0-1)

This is the name, title, and telephone number of the official who is authorized to review and approve the transmission of the FinCEN DOEP. There may only be one occurrence of this party for each FinCEN DOEP Activity in the batch. This party corresponds with Part IV of the FinCEN DOEP.

### 2.1.5. DesignationExemptActivity

As the container for information about the details of the FinCEN DOEP, this element identifies type of exempt person and the effective date of the exemption associated with the FinCEN DOEP. This element must be recorded after the final Party element is recorded for the FinCEN DOEP. There must only be one occurrence of this element for each FinCEN DOEP Activity in the batch. This element corresponds with Part I (Item 2) and Part II (Item 16) of the FinCEN DOEP.



## 3. FinCEN DOEP XML Batch Reporting Requirements

This section describes in detail the reporting requirements for each element in the FinCEN DOEP batch.

### 3.1. Element Definition Overview

Each element in this user guide is defined using the following terms:

Item	Description
<b>Element Name</b>	This is the name that must be used when recording the element.
<b>minOccurs/maxOccurs</b>	<p>This defines the number of times the element can occur for the parent element.</p> <ul style="list-style-type: none"> <li>• <b>MinOccurs.</b> The minimum number of times this element may be recorded for the parent element (e.g. minOccurs=0 means this element is only required under certain conditions while minOccurs=1 means at least one of the element must be recorded for the parent element in the FinCEN DOEP).</li> <li>• <b>MaxOccurs.</b> The maximum number of times this element may be recorded for the parent element (e.g. maxOccurs=99 means this element can occur up to 99 times in the same FinCEN DOEP).</li> </ul>
<b>Description</b>	This is the summary description of the element. Included in the description is a list of sub-elements associated with the element (if applicable) as well as any special requirements for when (and when not) to record the element.
<b>Attribute(s)</b>	This specifies the attribute(s) that are required to be recorded for the element. Various elements contain the <b>SeqNum</b> attribute used to identify the associated element in the batch file. The value recorded for this attribute must be numeric and unique.
<b>Parent Element</b>	This identifies the element's container element. The <Parent> element contains sub elements and is considered a complex element.

Item	Description
<b>Element Restriction(s)</b>	<p>This specifies the requirement level for the element; specifically, under what conditions the element should be recorded. Elements that must be recorded will be labeled as "Required", for example "Required. This element must be recorded." Elements that are required based on certain conditions will indicate the conditions upon which the element must be recorded, for example "Record this element when the party type is associated with the Exempt Party; Otherwise, do not record this element."</p> <p>NOTE: If neither of the above restrictions are specified for the element, then the element is not required. However, a field that is not required does not mean that it is optional. All fields require an entry when the filer has the relevant data.</p> <p>This specifies any requirements and/or restrictions involving the value recorded for the element.</p>
<b>Value Restriction(s)</b>	This specifies any requirements and/or restrictions involving the value recorded for the element.
<b>Remarks</b>	<p>This specifies any additional information about the element to assist with reporting; including:</p> <ul style="list-style-type: none"> <li>• Reporting conditions that may result in a batch rejection.</li> <li>• Reporting conditions that may result in a batch accepted with warnings.</li> </ul>
<b>Example</b>	<p>This provides one or more examples of how to record the element.</p> <p>PLEASE BE ADVISED: Most element examples are of scenarios where data is recorded; however, there are valid scenarios where the element may be recorded with a null value or not recorded at all when unknown or not applicable (see examples below):</p> <ul style="list-style-type: none"> <li>• SCENARIO: When NOT to record the element (e.g. "...otherwise, do not record this element.") <i>What this means:</i> The element tag should not be recorded unless the condition described in the Element Restrictions is present.</li> <li>• SCENARIO: When NULL is an acceptable value (e.g. "The value recorded is not equal to Y or is not equal to null.") <i>What this means:</i> The element tag may be recorded without a value and still be considered valid. For example: <ul style="list-style-type: none"> <li>○ <code>&lt;fc2:ExemptionRevokedIndicator/&gt;</code></li> <li>○ <code>&lt;fc2:ExemptionRevokedIndicator&gt;&lt;/fc2:ExemptionRevokedIndicator&gt;</code></li> </ul> </li> </ul> <p>NOTE: Although the above scenarios are technically valid, it is best practice to omit the element rather than record it with no value.</p>

**IMPORTANT:** FinCEN strongly encourages that filers first test their XML batch files for schema compliance using the schemas available at [www.fincen.gov/base](http://www.fincen.gov/base). Your batch file should pass schema validation before you attempt to submit to FinCEN. Otherwise, it will be at risk of being rejected.

### 3.2. Batch Validation (Form & Fit) Overview

It is important to note that if the batch file does not adhere to the basic format described in this guide in accordance with the FinCEN DOEP XML batch schema, then the batch will fail schema validation and will not be accepted by FinCEN.

Here is a list of general schema requirements that your batch must adhere to in addition to the data requirements described for each element throughout this guide. These schema requirements apply to all elements in the batch:

- Element names must include the prefix "fc2" in both the opening tag and closing tag.
- Element names must be spelled correctly and in the correct case. Do NOT include spaces at the beginning or ending of the element names.
- Elements must have a matching closing tag (which includes a self-closing tag in the event that no value is recorded for the element).
- Elements must be in the correct sequence.
- Elements must be recorded when the minOccurs=1 (or greater than 1).
- Elements must not be recorded more than the maxOccurs value for the associated <Parent> element.
- Element values must not exceed the maximum specified character limit.
- Element values must not include leading and/or trailing spaces.
- Element values must not include non-printable characters, such as carriage returns, line feeds, and tabs.

## 4. FinCEN DOEP XML Element Requirements

The following defines each element in the FinCEN DOEP XML batch in the order in which they can be recorded.

### 4.1. XML declaration/prolog

Description:	XML declaration/prolog. This is the XML declaration which specifies the XML version and character encoding used in the file. The XML declaration must appear on the first line of the file.

Remarks:	The batch submission will be <u>rejected</u> if any of the following conditions are true: <ul style="list-style-type: none"><li>The XML declaration/prolog is not recorded with the required values (see Value Restriction(s) above) or it is not recorded on the first line of the batch file.</li></ul>				
Example:	<?xml version="1.0" encoding="UTF-8"?>

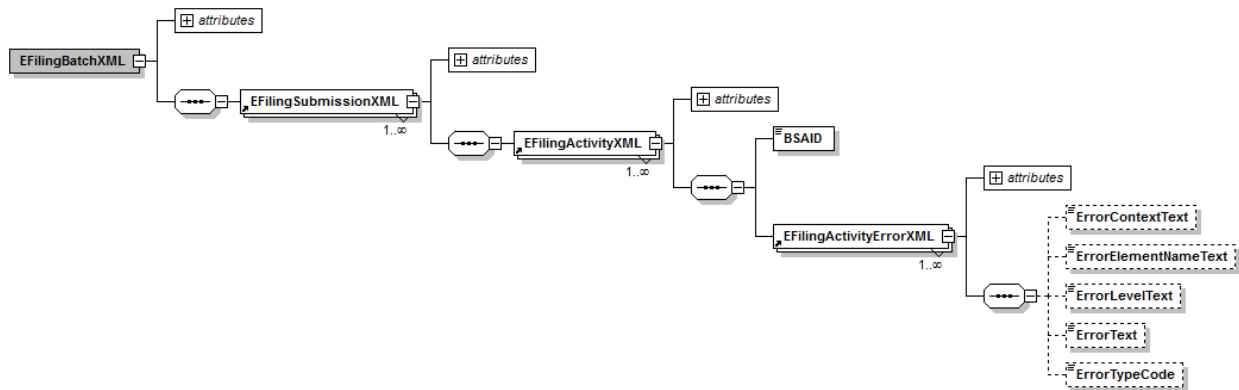

## 8. Attachment B – Error Correction Instructions

This attachment identifies the requirements and procedures for correcting FinCEN DOEP errors reported to batch filers during the FinCEN DOEP acknowledgement process.

### Error Categories:

There are two main categories of errors identified in batch files: Schema validation errors that result in automatic rejection of the batch file and data errors that represent errors in data entered for individual elements but may not result in a rejection.

Schema validation errors prevent the batch file from being processed and are considered fatal errors. An example of a schema validation error is a missing required element or an element sequence that does not match the schema. An example of a data error is a required element that contains no value.

Data errors are classified as primary or secondary warnings, depending on their importance. Primary warnings are file errors that violate electronic filing requirements or instructions and so degrade FinCEN DOEP data quality that they must be corrected. Primary warnings make it difficult for regulators, analysts, and law enforcement investigators to locate the FinCEN DOEP in the database or identify the nature and circumstances of the FinCEN DOEP. Examples of such warnings include blank last names or legal names, missing financial institution Employer Identification Numbers, or an invalid entry in the FinCEN DOEP date field. Attachment A – Error Descriptions identifies primary errors by adding an asterisk (\*) to the error code.

Secondary warnings are data errors that violate electronic filing requirements or instructions but have a lesser impact on FinCEN DOEP data quality. Examples of secondary errors are ZIP Codes that end in four zeros (e.g. 123450000), missing dates of birth, or invalid telephone numbers.

### Correction Requirements:

Filers should immediately correct and resubmit a batch file rejected for fatal errors when notified by FinCEN the batch file was not accepted.

When an accepted batch file contains FinCEN DOEP with primary warning errors, those FinCEN DOEP must be re-filed as a corrected report with the primary errors and any secondary errors corrected. FinCEN DOEP that contain only secondary errors need not be corrected. FinCEN requires that filers prevent all reported errors in their future filings. FinCEN recommends that data error corrections be made no later than 30 days after receiving error notifications. Furthermore, FinCEN recommends that filers remedy any systemic problems in their electronic submissions within 30 days of receiving error notifications. If technical issues prevent filers from implementing corrections within these time frames, filers should notify FinCEN by writing to:

This correspondence should explain the technical issues involved that prevent meeting the time frame, provide an estimate of when the issues will be resolved, and include a contact name and telephone number.

### Correction Procedures:

FinCEN DOEP batch files are rejected when they contain fatal format errors. Filers must correct all fatal errors identified in the batch file and resubmit the batch file to BSA E-Filing. Because they were not accepted by FinCEN, initial report FinCEN DOEP in the re-submitted batch file are still initial reports. Do not identify FinCEN DOEP from a rejected batch file as Amended reports unless they originally were filed as Amended reports.

If errors in a FinCEN DOEP from an accepted batch file involve primary warning errors, filers should correct all errors (primary and secondary warning errors) and file an amended report on that FinCEN DOEP using the following procedures:

- Make the corrections to all errors in the FinCEN DOEP in the accepted batch file.
- Record "Y" in the ExemptionAmendedIndicator element under the Activity Association parent element in each FinCEN DOEP to be amended.
- Record in the EFilingPriorDocumentNumber element under the Activity parent element the BSA Identifier (from the FinCEN DOEP Acknowledgement) that was assigned to the FinCEN DOEP being amended.
- Ensure that the FilingDateText element contains a new date.
- Complete all other data in the FinCEN DOEP in their entirety.
- Transmit the amended FinCEN DOEP in a new batch file. Do not re-transmit the original batch file because this will cause duplicate database entries on FinCEN DOEPs that were not amended.

## 9. Attachment C – Electronic XML Filing Instructions

The following instructions apply only to the electronic filing of the Designation of Exempt Person (DOEP) report, FinCEN Form 110, through FinCEN's BSA E-Filing System. These instructions do not apply to any other current or prior Bank Secrecy Act reports.

### General Information

The Bank Secrecy Act and its implementing regulations require banks to file currency transaction reports on transactions in currency of more than \$10,000. The regulations also permit a bank to exempt certain customers from currency transaction reporting in accordance with 31 CFR 1020.315.

Banks are the only type of financial institutions that may exempt customers from CTR filing requirements. The term bank is defined in 31CFR 1010.100(d); and includes savings and loan associations, thrift institutions, and credit unions.

The customers that the bank may exempt are called "exempt persons." An exempt person may be a bank, government agency/government authority, listed company, listed company subsidiary, eligible non-listed business, or payroll customer.

A bank may, but is not required to, use this report to notify the Treasury that the bank has revoked the designation of a customer as an exempt person.

FinCEN encourages banks to use the exemption procedure to the fullest extent. FinCEN reminds banks of their continuing obligation to monitor for and report suspicious activity with respect to transactions of all customers, including currency transactions conducted by exempt persons.

### General Instructions

1. **Filing:** The DOEP should be e-filed through the BSA E-Filing System. Go to <http://bsaefiling.fincen.treas.gov/index.jsp> to register. Any bank that wishes to designate a customer as an exempt person must file the DOEP no later than 30 days after the first transaction to be exempted.
2. **Report Completion.** Complete the report in accordance with instructions for each item. Unless there is a specific instruction to the contrary, leave blank any items that do not apply.
3. **Dates.** Discrete DOEP filers must enter dates in MM/DD/YYYY format with MM = month, DD = day, and YYYY = year. Single digit months and days must begin with a zero. Batch filers must enter dates in YYYYMMDD format.
4. **Numbers.** Enter all numbers such as identifying and telephone numbers as single number strings without formatting or punctuation such as spaces, hyphens, or parenthesis.
5. **Addresses.** Enter the permanent street address, city, two-letter state or territory abbreviation, and ZIP Code. Provide the apartment number or suite number, if known, following the street address. A non-location address such as a post office box or rural route number should be used only if no other street address information is available. ZIP Codes must be five or nine digits. ZIP Codes must be entered without formatting or special characters such as hyphens. For example, the ZIP Code 12354-6120 would be entered as 123546120. Complete any address item that is known, even if the entire address is unknown. No abbreviations are permitted in city names, which must be completely spelled out. A U.S. city name should match the city name used by the U.S. Postal Service for the associated state and ZIP Code. Use only the authorized U.S. Postal Service state, territory, or military address abbreviations found at <https://www.usps.com/ship/official-abbreviations.htm>. When a Transmitter address involves a U.S. Territory the both state and country items elements must contain the U.S. Territory code as found in ISO 3166-1. Foreign batch filers who are completing the Transmitter Address element with foreign address information must use only the Canadian and Mexican state/territory/province codes and ISO country codes approved for use by FinCEN. For Canadian provinces and territories use the Canada Post Corporation codes found at <http://www.canadapost.ca/tools/pg/manual/PGaddress-e.asp#1380608>. For Mexican states and territories use the ISO 3166-2 three-letter codes found at [http://www.commondatahub.com/live/geography/state\\_province\\_region/iso\\_3166\\_2\\_state\\_codes](http://www.commondatahub.com/live/geography/state_province_region/iso_3166_2_state_codes). For all

countries use the ISO 3166-1 two-letter country codes found at [http://www.iso.org/iso/country\\_names\\_and\\_code\\_elements](http://www.iso.org/iso/country_names_and_code_elements). NOTE: The ISO 3166-2 country list contains the code "UM" that stands for the United State Minor Outlying Islands. Using "UM" in country fields is prohibited. These islands are uninhabited. As such they have no addresses.

**6. Prohibited Words.** Do not use the following words or their variations in fields:

- a. AKA
- b. CUSTOMER
- c. DBA
- d. NONE
- e. NOT APPLICABLE
- f. OTHER
- g. SAME
- h. SAME AS ABOVE
- i. SEE ABOVE
- j. UNKNOWN
- k. VARIOUS
- l. XX

**7. Name Editing Instructions.** Because many names do not consist of a single first name, middle name, and last name, care must be taken to ensure these names are entered properly in the BSA SAR. This is especially important when there are separate fields for the last name, first name, and middle name. Some names have multiple surnames (family names) or multiple given names that do not include a middle name. Others may not be written in [first name] [middle name] [last name] order. Multiple surnames must be entered in the last name field. For example, Hispanic names may be written in the order of given name, father's last name, and mother's last name, e.g., "Juan Vega Santiago." Thus the surname "VEGA SANTIAGO" would be entered in the last name field with "JUAN" entered in the first name field. Some Hispanic surnames consist of three names (e.g., father's last name, mother's last name, and husband's father's last name in the case of a married woman). In that case all three would be entered in a last name field. Hispanic names do not have middle names, so a multiple Hispanic given name such as "Rosa Maria" would be recorded in the first name field. In some cultures names consist of multiple first names and a single family name, not necessarily in (first name) (last name) order. For example, the Korean name "Kim, Chun Nam" consists of the family name "Kim" and the first name "Chun Nam" separated by a comma and space. There is no middle name. In this case "KIM" would be entered in the last name field and "CHUN NAM" would be entered in the first name field. Nothing is entered in the middle name field. When an individual name is entered in a single name field it should be entered in [first name] [middle name] [last name] order regardless of any foreign naming conventions. Thus, "Kim, Chun Nam" would be entered as "CHUN NAM KIM" in a single name field. Punctuation and special characters should be used in names only when they are part of the name. For example, the period in "Expedia.Com" should be included because it is part of the name. Placing a period after a middle initial would be prohibited because the period is not part of the middle name. Abbreviations in names are prohibited unless an abbreviation is part of a legal name. Entry of middle initials is permitted when a middle name is unknown. A name suffix may be abbreviated, i.e. Junior can be JR, Senior can be SR, the Third can be III, etc.

## Specific Instructions

### Part I Filing Information

**Item 1. Type of filing.** Check only one of the three boxes 1a "Initial designation," 1b "Exemption amended," or 1c "Exemption revoked." If the DOEP amends or revokes a prior designation, include the Document Control Number or BSA Identifier of the prior filing in the associated number field. If this number is unknown, enter "00000000000000" in the number field. Leave the number field blank if the filing is an initial designation.

**Item 2. Effective date of the exemption.** For an initial designation, enter the date of the first transaction to be exempted. For amended DOEPs, if the effective date of the exemption is not being amended, the date entered should

be the same date the bank used in the “effective date of the exemption box” when the initial designation was made. If the effective date of the exemption is being amended, enter the revised date of the first transaction to be exempted. If an exemption is being revoked, enter the day after the date of the last transaction that was exempted.

## Part II Exempt Person Information

**Check here if entity.** Check this box if the exempt person is an entity. Leave this box blank if the exempt person is an individual.

**Item 3. Individual’s last name or entity’s legal name of the exempt person.** If the exempt person is an entity, enter the full legal name of the exempt person as it is shown on the charter or other document creating the entity. For exempt individuals such as sole proprietorships, enter individual’s last name.

**Item 4. First name.** Enter the first name of the exempt person if an individual.

**Item 5. Middle name.** Enter the middle name or initial of the exempt person if an individual.

**Item 5. Suffix.** Enter the name suffix such as JR, SR, III, etc. of the exempt person if an individual.

**Item 6. Alternate name.** Enter the individual’s also known as (AKA) or the entity’s doing business as (DBA) name if different from the name entered in Items 3-5. Do not include the acronyms AKA or DBA with the name.

**Item 7. Occupation or type of business.** Record the occupation, profession, or type of business of the exempt person. Use specific descriptions such as doctor, carpenter, attorney, used car dealership, plumber, truck driver, hardware store, etc. Do not use non-descriptive occupations such as businessman, merchant, retailer, or self-employed without indicating the nature of the occupations, e.g. shoe merchant or self-employed accountant.

**Item 7a. NAICS Code.** Select the North American Industry Classification System (NAICS) code for the occupation entered in Item 7. Batch filers should only use codes from the NAICS Code list on the BSA E-Filing Web Site at <http://bsaeifiling.fincen.treas.gov/main.html>.

**Item 8. Address.** Enter the permanent street address of the business location of the exempt person. For exempt persons doing business at more than one physical location, enter the local headquarters address or local address of the exempt person. For individuals such as sole proprietorships, enter the business address of the individual rather than the home address, unless they are the same (see General Instruction 5).

**Item 9. City.** Enter the city associated with the business location of the exempt person. Do not abbreviate the city name (see General Instruction 5).

**Item 10. State.** Select the state or territory associated with the business location of the exempt person (see General Instruction 5).

**Item 11. ZIP Code.** Enter the ZIP Code associated with the business location of the exempt person. Use only the five or nine-digit ZIP Code assigned to the address by the U.S. Postal Service (see General Instruction 5).

**Item 12. TIN.** Enter the Employer Identification Number (EIN) or Social Security Number (SSN) of the exempt person. If a sole proprietorship does not have an EIN, enter the proprietor’s Social Security Number (SSN).

**Item 13. TIN type.** Select the TIN type associated with the TIN in Item 12.

**Item 14. E-mail address.** Enter the e-mail address associated with the exempt person.

**Item 15. Phone number.** Enter the telephone number of the exempt person. Enter as a single number string without formatting and punctuation such as spaces, hyphens, or parenthesis.

**Item 15a. Extension.** Enter the telephone number extension of the exempt person.

**Item 16. Type of exempt person.** Check only one of the four boxes 16a “Listed company,” 16b “Listed company subsidiary,” 16c “Eligible non-listed business,” or 16d “Payroll customer.”

## Part III Filer Information

**Item 17. Name of bank.** Enter the bank’s full legal name.

**Item 18. EIN.** Enter the bank's EIN.

**Item 19. RSSD.** Enter the bank's Research Statistics Supervision Discount (RSSD) number.

**Items 20 - 23. Address.** Enter the bank's headquarters address (See General Instruction 5 and Part II address instructions for additional information on completing the filer address.).

**Item 24. Primary federal regulator.** Select the bank's primary federal regulator from the list. The options are:

- Federal Reserve Board (FRB)
- Federal Deposit Insurance Corporation (FDIC)
- Internal Revenue Service (IRS)
- National Credit Union Administration (NCUA)
- Office of the Comptroller of the Currency (OCC)

**Item 25. Affiliated banks.** A parent holding company or one of its bank subsidiaries may make the designation of exempt person on behalf of some or all holding company bank subsidiaries so long as the designation lists each bank subsidiary that will treat the customer as an exempt person. Check the box in Item 25 and complete an Affiliated Bank Information section on each affiliated bank. Batch filers will complete an Exempt Affiliated Bank Party element on each affiliated bank included in the DOEP. Up to 99 affiliated banks can be included in a single DOEP.

## Part IV Signature

**Item 26. Print name.** Enter the name of the bank official who authorized the exemption.

**Item 27. Title.** Enter the title of the bank official who authorized the exemption.

**Item 28. Signature.** This report is signed when the discrete report or batch file is signed with a personal identification number (PIN) assigned to an appropriate bank official by the BSA E-Filing System.

**Item 29. Phone number.** Enter the telephone number of the bank official who authorized the exemption.

**Item 29a. Extension.** Enter the telephone number extension of the bank official who authorized the exemption.

**Item 30. Date of signature.** If the DOEP is a discrete filing, this date will be supplied by the BSA E-Filing System when the report is signed with a PIN. Batch filers must enter the signature date in YYYYMMDD format.

**Paperwork Reduction Act Notice:** The purpose of this report is to provide an effective means for banks and depository institutions to exempt eligible customers from currency transaction reporting. This report is required by law, pursuant to 31 CFR 1020.315 Federal law enforcement and regulatory agencies, including the U.S. Department of Treasury and other authorized authorities, may use and share this information. You are not required to provide the requested information unless a report displays a valid OMB control number. Public reporting and recordkeeping burden for this report is estimated to average 70 minutes per response, and includes time to gather and maintain information for the required report, review the instructions, and complete the information collection. The record retention period is five years. Send comments regarding this burden estimate, including suggestions for reducing the burden, to Financial Crimes Enforcement Network, Attention: Paperwork Reduction Act, P. O. Box 39, Vienna, VA 22183-0039.

## 10. Attachment D – Secure Data Transfer Mode Filers

FinCEN provides the ability for filers to submit the FinCEN DOEP XML batch file securely via the Internet using a VPN device or Connect:Direct software. This method of filing is referred to as Secure Data Transfer Mode (SDTM). SDTM allows for a secure, system to system mechanism for transferring batch submissions from your organization's internal server to the BSA E-Filing server. The batch submission process can be automated such that user intervention/involvement is minimized. There is no interaction with the BSA E-Filing system web site for the upload of the batch file but the BSA E-Filing system web site is used to track the status of the submissions.

For filers using this option for filing, SDTM filers can submit a single file containing the FinCEN DOEP XML batch data. The file naming convention is as follows:

**Submission type:** DOEPXST

**Date/Time:** This will be a date-time stamp to guarantee filename uniqueness

- Year = YYYY
- Month = MM
- Day = DD
- Hour = hh
- Minute = mm
- Second = ss

**Organization name:** Custom naming by the submitting organization (e.g. "ABCPreparingFirm")

**Extension:** xml

**Example FinCEN DOEP XML batch file name:** DOEPXST.20170609153015.ABCPreparingFirm.xml

**Corresponding FinCEN DOEP XML batch Acknowledgement file name:** This file name will match the corresponding input FinCEN DOEP XML batch file name with the text "\*.ACKED" appended to the end.

For example: DOEPXST.20170609153015.ABCPreparingFirm.xml.ACKED
